STRUCTURE

Members of the PCC are either ex-officio or elected at the Annual Parochial Church Meeting (APCM) and in accordance with Church Representation Rules (Rule 16 [1]) one third of the members of the Parochial Church Council are required to retire each year but may stand for re-election.

Standing Committee

This is the only committee required by law. It has the power to transact the business of the PCC between its meetings, subject to any directions given by the Council.

CHURCH MEMBERSHIP

There are 96 parishioners on the Church Electoral Roll (2018 – 113) of whom 10 are not resident in the parish.

REVIEW OF THE YEAR

Parochial Church Council (PCC)

The PCC met 6 times during the year, with 90% attendance.

Meetings of the International & UK Mission Committee and Social, Outreach & Fundraising Team (SOFT) were held and minutes of their meetings were reported to the PCC as were those of the committee of Christians Together in Elmswell, of which St John's is a member.

Worship: St John's is a diverse congregation made up of all ages and our worship reflects this. In 2019, we continued the pattern of services introduced at the beginning of 2017. On the third Sunday in the month Breakfast Church is an informal and contemporary service with breakfast available from 9am. This is followed at 11am by Common Worship Communion with traditional organ. On other Sundays, there continues to be a variety of worship styles. Average Sunday attendance was 57 adults and 12 children. During October, the month used for Diocesan statistics, the average attendance was 48 adults and 7 under 16's. (2017 - 52 adults and 8 under 16's).

2019 continued with the Messy Church fresh expression of Church. This started off as a weekly meeting in August 2018 (replacing the August holiday club) and initially continued monthly. It met weekly during August and now continues in half-terms breaks and the Easter break. It continues to attracts between 18 and 35 children and up to 25 adults (including those helping).

A number of special services were held in 2019, including Ash Wednesday, Maundy Thursday, Good Friday, Ascension Day, Time to Remember, Remembrance Day, and Christmas services. It was good to see 223 in church for the School Carol Service as well as 129 for Little Elms (nursery) Carols. Some services were designated as special services of healing.

Mission and support agencies continue to be supported – OMF, Tearfund, the Stowmarket Foodbank, CPAS, Gatehouse and Mercy Ships amongst others.

Weekly prayer meetings and midweek Bible Study groups (3 house groups and Mums the Word!) met. The Open the Book team and the clergy took assemblies at the School. Year 5 and 6 came to the church for Discover Advent. The Ladies' Monthly Lunch Group, Men's Breakfast and Monday Coffee Break all continued, as did our Sunday children's groups. Fund raising events were successful, including 2 quiz nights, "Nutz & Botz" concert, "Variety and Spice" concert and the traditional Christmas Fair. The Summer Fair is currently not being held, with the fund-raising focus diverting to the popular quiz nights and concerts.

The Friends of St John's has raised over £50,000 for the Fabric of the church since 1995. Activities in 2019 included the usual Coffee Morning, the Friends' annual service, Afternoon Tea at the Wesley preceded by a Beetle Drive and a lunch in church after the harvest service. A small group was formed to organise Lent Lunches, with profits going to Mission Aviation Fellowship. We are trying to recruit new members.

Christians Together in Elmswell includes St John's, the Baptist Church and some members of Norton Salvation Army. At Christmas CTIE sang carols on the Green for the second year, followed by refreshments in the Baptist Church. This attracted in the region of 50 people. Other joint services take place during the year, at Easter and Pentecost, at which the talks are given by representatives of the three churches.

Summary: 2019 was a mixed year. We can see definite opportunities in initiatives such as Messy Church and continue to make links through baptisms, weddings and funerals. However, encouraging regular attendance takes time. Additionally, existing child members of St John's are growing up and moving to university or finding other activities more appealing than church. The ever-increasing parish share is a challenge, but was paid in full thanks to excess money left over from the Chancel project. However, Elmswell continues to be a growing village and we look to God as we continue to serve him faithfully, praying we will bring him glory in all we do.

FINANCIAL REVIEW

Parish Share

The major expense each year is the Parish Share, which is St John's contribution to the Diocesan Purse. We paid off the 2019 Parish Share in full (£67,865) by the end of December 2019. This was a considerable achievement as the value was higher than ever before (2016 = £58,224, 2017 = £64,577, 2018 = £66,972) and continues to increase each year.

Donations – Gift Day, Contactless, Online and CAF

In previous years (2016 and 2017) we held "gift days" in the following January and received a number of generous donations which allowed us to pay off the Parish Share for those years, however in 2019 (and 2018) no gift day was required.

Since Mid-November 2019 we have had a contactless giving machine in our church. This allows people to simply tap a credit/debit card and make a donation (£5 default). In 2019, we received £36 (after charges) in donations via this method.

We also have the ability to receive donations via an online giving webpage (Virgin Money). This has allowed people from further afield to easily make donations to St John's and some people have opted to give regularly through this website.

We also continue to receive a number of donations through the giving scheme Charities Aid Foundation (CAF).

Virgin Money and CAF can reclaim the Gift Aid directly from HMRC on St John's behalf.

Fabric Fund

In 2019 we received some exciting news regarding our Fabric Fund. A generous legacy will generate several thousand pounds per year to the St John's Fabric Fund for the next 100 years. Currently, the balance of the Fabric Fund is £1,339.

The Friends of St John's continue to fundraise for the Fabric Fund and, looking forward, we predict the Fabric Fund account will be healthy.

Grants

A £5,495 grant was received in February 2019 via the Listed Places of Worship (LPW) Grant Scheme. This gives grants that cover the VAT incurred in making repairs to listed buildings in use as places of worship. The scheme covers repairs to the fabric of the building, along with associated professional fees, plus repairs to turret clocks, pews, bells and pipe organs. The grant was to cover the VAT element of the Chancel and South Aisle repairs.

Fundraising

2019 was another amazing year for fundraising at St. Johns. There were numerous fantastic events put on, including two quizzes, raising approximately £1,100 in total. There was also the "Nutz and Boltz" and "Variety and Spice" evenings raising over £900 between them, whilst the Christmas Fair continues to be a successful fundraiser, this year raising approximately £3,100 for the church funds.

Charitable Giving and Mission Work

Typically, we raise money for charities via specific in-service collections or post-service fundraisers. Charities we have supported in 2019 include Tearfund (£240 total donations) and Royal British Legion for their poppy appeal (donation of just under £400). We have also supported Samaritan's Purse (for their Hurricane Dorrian appeal), CPAS (through the moneybox giving) and Mercy Ships.

RISK ASSESSMENT

The PCC has previously carried out a detailed review of the church's activities (as Charity Trustees) and produced a comprehensive, strategic plan setting out the major opportunities available to the Church and the risks to which it is exposed. The PCC monitors progress against the strategic objectives set out in the plan at each meeting and a comprehensive review of the plan is carried out annually. As part of this process the PCC has implemented a risk management strategy which covers:

- 1. **Financial Risks** this is the most common risk to be managed through budget, internal audit and proper financial procedures.
- 2. **Reputational Risk** unwelcome publicity which hinders the mission of the Church.
- 3. **Statutory and Legal Requirements** to cover health and safety, employment law, child protection and associated difficulties which could lead to compensation claims.
- 4. Operational Risk threats to the Church's ability to deliver its objectives.

The PCC (as Charity Trustees) have established systems and procedures to mitigate those risks identified in the plan through recording, PCC authorisation and review. The PCC is satisfied the above risks have been reduced to their minimum, by systematic consideration and assessment regarding both the level of risk and the Health and Safety procedures relating to each of the above areas.

NOTES TO THE FINANCIAL STATEMENTS

1. ACCOUNTING POLICIES OF THE PAROCHIAL CHURCH COUNCIL (PCC)

The Financial Statements have been prepared in accordance with the Church Accounting Regulations 2006 using the accruals basis and comply with the Charities Act 2011 (SORP 2010).

Funds

The General Purpose Fund represents funds of the PCC that are not subject to any special restrictions regarding their use and are available for application to the general purposes of the PCC. These include funds designated for a particular purpose by the PCC.

The accounts include monetary transactions, assets and liabilities for which the PCC can be held responsible. They do not include the accounts of other Church groups that owe an affiliation to another body, nor those that are informal gatherings of Church members.

Statement of Assets and Liabilities

The following assets are recognised but not valued in the Statement of Assets and Liabilities:

- Moveable church furnishings held by the churchwardens on special trust for the PCC and which require a faculty for disposal.
- Land and buildings held on behalf by the PCC.
- Other fixtures and fittings where the PCC is free to dispose of such assets without faculty and where the original cost exceeded £1,000.

2. ENDOWMENT FUNDS

The following are capital funds and the PCC may only use the income generated from these investments:

Martyrs Memorial & Church of England Trust Fund

This fund represents the proceeds of the sale of the old Church Hall in School Road in 1988, after deduction of expenses incurred following the re-ordering at the West end of the church in 1993 when the Church Room, Balcony, Kitchen and Toilet were built. The balance to be retained as capital with the PCC able to use the investment income for general purposes or for the maintenance of the fabric. At one time part of this income was reinvested but the current financial situation no longer allows this.

A special exception was made in 2000 when the PCC was granted permission to temporarily withdraw £10,000 capital from the Fund due to the urgent need to carry out repairs to the chancel roof. Thanks to fund raising and the provision of grants the capital was repaid in 2001.

A further exception was made in 2017 when the PCC was granted permission to withdraw £25,000 capital from the Fund due to the urgent need to carry out repairs to the chancel roof.

Diocesan Trust Fund

This fund comprises money given to St John's with specific instructions that it be retained as capital with the PCC able to use the investment income for general ecclesiastical purposes or for the maintenance of the fabric of the church. There was no further investment in The Church of England Central Board of Finance Investment Fund during 2019.

3. CONNECTED CHARITIES

The Friends of St John's Church - Elmswell (Registered Charity No. 1083116)

The organisation raises funds for the upkeep of the church building. The PCC Fabric Fund for 2018 shows an income of £2,000 from The Friends of St John's Church – Elmswell. There was no income in 2019. The accounts are not included in the PCC's financial report as they are a registered charity in their own right and make their own return to the Charities Commission.

Elmswell Church Land Charity (Registered Charity No. 255055)

A charity set up in 1898 for the maintenance of the fabric of the Parish Church of Elmswell, inclusive of the tower, but exclusive of the chancel.

4. PAYMENTS TO TRUSTEES

Any payments made to Trustees (PCC Members) solely relate to reimbursement of expenses incurred in respect of the administration of St John's Church PCC.

5. The FABRIC FUND includes a balance of ± 107 in respect of the Handbells Account.
